2. Display the work whole or in part in workshops, presentations, articles, texts, brochures, textbooks and other publications
3. Display the work whole or in part to promote the academic and research mission of the School of Informatics, including fundraising activities
4. With notification to faculty and students, submit the work to appropriate competitions, when applicable
5. Build upon design elements in the work for future professional projects

6. If the project results in significant ongoing data collection, the project sponsor will allow SOI faculty continued access to the collected data for the purpose of scholarly analysis and research publications.

The Indiana University School of Informatics student development team members working on the project may:

1. Display the work whole or in part as part of their resumes, curriculum vitae or professional technology portfolios
2. Build upon design elements in the work for future professional projects

The restrictions in this agreement shall cover both the final and any draft, interim or derivative versions of the work. This agreement may be executed in multiple counterparts, each of which will be deemed an original, and all of which shall constitute but one instrument.
